**READ THIS FORM CAREFULLY BEFORE COMPLETING AND SIGNING IT.**

Under the Nevada Revised Statute 645.330, an applicant for a broker's license must have at least two years of active, full-time experience as a licensed real estate salesman in this state, another state, or the District of Columbia, out of the four years immediately preceding the issuance of a broker's license.

For experience as a real estate salesman to be considered "active, full-time," an applicant must have worked a minimum of 30 hours per week during at least 48 weeks of any 12-month period. Mere possession of a salesman license does not count toward qualification for a broker's license.

Experience as a real estate salesman may also allow the applicant to receive college credit. The equivalent of 16 semester units of college level credit is awarded for each two years of active, full-time experience, if an applicant is a licensed real estate salesman (NRS 645.343). This form also serves as verification for this purpose.
